There were many people of America that were concerned about the "Change" that was uttered by the Obama camp during the 2008 presidential campaign. Who would have known that part of that change would be numerous constitutional breaches.

As many know, the Census is being taken this year of 2010. To begin this adventure, we must look at the brave new way this is being executed : It is now done by the Office of the President. The reason this particular "*change*" has been reportedly done is that there were many people who were missing in the "head count", which included Indians on the Reservations. Of course for those who understand the Constitution comprehend that this makes no sense whatsoever; or, does it, in the *minds of the insane*?

Having this information understood, the current regime of Washington DC, under the guidance of Barrak Hussein Obama, has established this in regard to the Census:

- How We Count America ~ The census numbers tell us who we are and what we need. Before we begin a new chapter in American history, we need to understand who we are right now. The 2010 Census aims to count all U.S. residents—citizens and non-citizens alike.

This bears repeating : "*Before we begin a new chapter in American history*" and "*The 2010 Census aims to count all U.S. residents—citizens and non-citizens alike.*"

The question is, what are "we" beginning and what does Obama think he is doing?

Historically, a census has been taken by the United States government to determine the number of representatives who are to represent each *State* in the *Union in Congress*. For your understanding, issues that are incorporated into the (a) constitution are a law form that is noted as "public law". Simply, such law has an effect on all people who are considered "citizens" or the members of a *body politic*. The Constitution for the United States of America is a document that is grounded in international law. To clarify, each state that is in the Union is a country (and nation). These nations have entered into agreement under the Federal Constitution. In sense, all law that is incorporated into the Constitution is deemed *quasi-public law* as it is "private" international law. For further clarification, one should understand that treaties are considered private international law. To expand your understanding, the term "congress" means an international assembly.¹

Now that we have laid-out some foundational principles of how the constitutional system works under international law, we can now address the makeup of the Census.

1 **CONGRESS.** In International Law. An assembly of envoys, commissioners, deputies, etc. from different sovereignties who meet to concert measures for their common good, or to adjust their mutual concerns. *Black's Law Dictionary, 4th edition*

The legal particulars of the Census (the original authorities) can be seen grounded in the body of the original Constitution. One could say that the cause or reason for the Census comes from Article I, Section 2, Paragraph 3, wherein it establishes :

- Representatives and direct Taxes shall be apportioned among the several States which may be included within this Union, according to their respective Numbers, which shall be determined by adding to the whole Number of free Persons, including those bound to Service for a Term of Years, and excluding Indians not taxed, three fifths of all other Persons.

The place where the Census is noted can be found in Article I, Section 9, Paragraph 4:

- No Capitation, or other direct, Tax shall be laid, unless in Proportion to the Census or enumeration herein before directed to be taken.

Okay, the question is : What Census? Moreover, who directs it to be taken?

If we look at Article I, Section 8, of the Constitution wherein the Congress has its powers enumerated, there is absence of authority to create a Census. Of course, we then have to wonder how and where the authority is provided. So, does this not maintain that the Census has always been a ruse since the founding of the Constitution?

Now that some foundational principles have been laid of how the Census purportedly works, we can now address the fundamental flaws of the 2010 Census.

If one looks at the website for the US Census of 2010 you will find various *sales pitches* throughout the site. The most interesting aspect is that they fail to acknowledge the main component that gives the Census its *contemporary* form : The 14th Amendment.

The particular reference in concern to bring us to a modern day formation of the Census is *Section 2* of the 14th Amendment. The section in mention is as follows:

- Representatives shall be apportioned among the several States according to their respective numbers, counting the whole number of *persons* in each *State*, excluding Indians not taxed.

As we can see, there are some vital components that are duplicated from those found in Article I, Section 2. It stands to reason that this section of the 14th Amendment overrides said article; however, on the Census site, we find that the government is only making reference to the obsolete section, which included the counting of "slaves". Why would this be? It has not been used in 142 years. Perhaps someone is *hiding* something.

To illustrate how the "new formula" under Section 2 of the 14th Amendment works, we must understand the mechanics of the words used. A common misconception of most *all* people is that "state" means a geographical location : It *does not*. The term "state" is the *body politic* or the *government* of such body politic. And for clarification, a people (a nation) live in a country, and each "state" is a country. Generally, the word or term noted as "country" references a geographical location. Hence, in theory, a state and/or nation can really exist anywhere, the land notwithstanding. Accordingly, the 14th Amendment formulates all Americans to be "residents", as Vattel sets forth that a "resident" is a man

in a country not his own.² That is to say, all US citizens³ are living in the *false* nation and/or country called "America", and not in their *true* countries but in the *political country* called *America*; wherefore they are counting ALL RESIDENTS.

Now, back in reference to the first parameter of the apportionment formula of Section 2 of the 14th Amendment,⁴ we can assimilate that, persons = citizens. And that the term State can be replaced with the phrase *body politic*. Hence : "...the whole number of *persons* in each *State*" = "...the whole number of *citizens* in each *body politic*"

As we have established herein, we find that the core purpose to take a census is to count the number of *people* who are present in a "state" for representation. Webster's Revised Unabridged Dictionary (1913) establishes this in regard to a census:

- **Census.** (n) An official registration of the number of the people, the value of their estates, and other general statistics of a country.

One of the component features of the 14th Amendment governmental system is to take money from the states and funnel it back to each according to their needs. By the way, for those who are not aware, that is a Marxist principle. Another Marxist principle is income tax, another component that was installed into the current governmental system in the year of 1913, which oddly enough is the same year of the above noted definition. Until that time, the "value of one's estate" was not really an issue of the Census. As many understand, the data gathering information for that is done on *April 15th* of every year, which is the income tax. In conjunction with the Census, the data mining is complete.

Accordingly, here is a sample of the "New America" under the 14th Amendment :

- A New Portrait of America. Every ten years, a Portrait of America is taken by the U.S. Census Bureau. The 2010 Census will provide a clear and detailed picture of our nation, and its results will be used to determine how \$400 billion in federal tax money is spent in states and communities. Prior censuses have told us our country's population is an extremely diverse one - and these videos, photos and audio files on the Portrait of America galleries celebrate that diversity.

Yes, a celebration of "diversity" as the working men have no country.⁵

Now we can go over the information that illustrates the direct fraud behind the Census of 2010. Here is some prominent propoganda from www.2010.census.gov :

- How It Affects the Nation. We Can't Move Forward Until You Mail It Back. That's why it's so important that you fill in the form and promptly mail it back. Census information affects the numbers of seats your state occupies in the U.S. House of Representatives.

Note that they are saying that one of the purposes of the Census is to assist in providing them numbers for computation for representation. The problem is, they are counting everyone that is within the control or jurisdiction of the United States. Remember that we noted above where they admit that "*The 2010 Census aims to count all U.S. residents—citizens and non-citizens alike.*" They are *admitting* they are involved in something that cannot produce an accurate number of people to be counted for what they profess. As they are counting "all people", the *Census Form* reflects that impossibility also.

Please understand that propaganda found on the government website is not law. There is a reason these people do not want you looking at *Section 2 of the 14th Amendment*. It is entitled *The Red Amendment* : the writing grounded in politics and law that blows apart the system of government that was put in place after the Civil War.

In closing, the Obama Administration is lawless and out of control, so it appears. But as many know Barrak Hussein Obama, *or whoever he is*, is just a puppet of the New World Order and is doing what he is told which *conforms* with what is found in the US Code:

Title 8 USC § 1101. Definitions (a) As used in this chapter -

(37) The term "totalitarian party" means an organization which advocates the establishment in the United States of a totalitarian dictatorship or totalitarianism. The terms "totalitarian dictatorship" and "totalitarianism" mean and refer to systems of government not representative in fact, characterized by - (A) The existence of a single political party, organized on a dictatorial basis, with so close an identity between such party and its policies and the governmental policies of the country in which it exists, that the party and the government constitute an indistinguishable unit, and (B) The forcible suppression of opposition to such party.

(40) The term "world communism" means a revolutionary movement, the purpose of which is to establish eventually a Communist totalitarian dictatorship in any or all the countries of the world through the medium of an internationally coordinated Communist political movement.

Well, what are those doing there? A plan, perhaps? And you thought the Republicans and Democrats were different parties and the President was just a President.
